REQUIRED LABELING FOR MAINTENANCE OF TRAFFIC (MOT) DEVICES

Now that your product has been approved the Department requires that a Qualified Products List (QPL) number be placed on each devices. It should be placed in a location on the device such that an inspector can readily view it from their vehicle.

On Warning Lights and Stop-Slow Paddles the required QPL number should be $\frac{3}{8}$ " in height and the optional information no greater than $\frac{1}{4}$ of the $\frac{3}{8}$ " height. For all other device the height should be 1" with the optional information no greater than $\frac{1}{4}$ of the 1" height.

It is the manufacturers responsibility to label all devices they sell for use on the State of Florida's roadways. If the label comes off it is the contractor's responsibility to have it replaced immediately.
